Subject: Providing Leased Line internet Connection in NILERD Campus – reg

1. The National Institute of Labour Economics Research and Development ((NILERD) is an autonomous organization under the administrative control of NITI Aayog, Govt. of India. At present the Institute has RF Leased line connection of 16 Mbps. However, the Institute would like to increase it to 20 Mbps of

which 10Mbps would be for the use of International Participants and remaining 10 Mbps would be for

use by NILERD faculty/staff.

2. In order to have uninterrupted internet facility to ensure smooth conduct of official activities and

business in the Institute, the Institute invites sealed quotations for providing of Leased Line Internet Connection in the campus. The Leased Line Internet Connection should have the following technical

specifications/provisions.

Service: Leased Line Internet Connection

Media: Fiber Optic (RF)

Bandwidth: (1:1) 20MBPS

Scope of Work: The Institute requires a dedicated Internet Leased Line connection of 20Mbps. The Internet leased line should enable the Institute to carry out a secure data

transfer over the digital Link. The vendor will carry out the complete installation and

implementation.

3. Terms and Conditions for inviting quotations:

i) Sealed quotations containing technical bid and financial bid both kept in a separate

envelope must be submitted on the letter head of the bidders.

ii) The technical bid should have the information regarding background of the company, its business and expertise, list of clients, annual turnover, technical manpower etc. in

prescribed format (Annexure-I)

- The financial bid in Annexure-II should indicate (i) one time expenditure (non-recurring) and (ii) annual charges/cost (recurring) for provision of **Leased Line Internet Connection** as per the technical specifications and requirement as indicated in **para 2 above**. The financial bid should also contain **EMD of Rs. 14,000/-** in the form of **Demand Draft** drawn in favour of **NILERD.**
- iv) Sealed quotation can either be sent to Administrative Officer, National Institute of Labour Economics Research & Development, Sector A-7, Institutional Area, Narela, Delhi-40 or dropped in the Tender box kept in General Section of the Institute. Last date for receipt of the quotations is <u>22.08.2016</u> up to 1.00 pm. The quotations will be opened on the same day (22.08.2016) on 2.30 pm.
- v) The bidder shortlisted on the basis of evaluation of technical bid will give presentation (if required) about their proposed plan of action before the committee constituted at specified date and time.
- vi) Any quotation that is received without EMD money will be rejected. The EMD (without interest) will be returned after finalization of the process.
- vii) The quoted price should clearly indicate the details of taxes separately otherwise it will be presumed that the quoted prices are inclusive of taxes.
- viii) Correction/over-writing in the quotation is not permissible. Every sheet of the quotations and the terms and conditions shall be signed and stamped by the authorized signatory of the Firm and enclosed with the quotation.
- ix) The prices quoted in the quotation will remain valid for a period of at least three months.
- x) The hardware items to be supplied shall carry a minimum warranty of one year from the date of supply.
- xi) The successful bidder on award of work shall be required to sign a Service Level Agreement with the Institute for network & services availability, average round trip delay packet delivery and maximum time to respond and to resolve a problem etc.
- xii) If the Items/services supplied are found to be substandard or do not conform to the specification, such defective items shall be required to be replaced by the bidder at their own cost.
- xiii) The successful bidder will be required to submit performance security either in the form of fixed deposit hypothecated to NILERD, or an account payee demand draft or in the form of bank guarantee which will remain valid for a period of 60 days beyond the date of warranty period.
