### 1. Background

The internet has changed the concept of initiating activities all over the world and now changing the procedure/methods dealing with the activities. While initiating the activities the first task is to adopt and use of information technologies from personal computer to complicated electronic data interchanges.

E-Governance, is the birth of a new market and the advent of new form of governance which is powerful force in the internet economy, bringing together citizen and business activities with a network of information, and knowledge. The Government of India has planned a national level initiative - National e-Governance Plan, (NeGP) to increase transparency, efficiency and effectiveness for delivery of services to the people of the country. E-Governance is a part of the Government's agenda of governance. Keeping in view the enormous task of driving NeG Plan in line with the overall spirit of service orientation most states are not adequately equipped in terms of personnel/professionals. To address the emerging gaps while implementing the NeG Plan the institute has designed (as part of its Capacity Building efforts to accelerate the implementation of the National e-Governance Plan), a training programme to address certain objectives so that the actual goal of NeGP can be achieved.

#### 2. Objectives of the Programme

- Components of National e-Governance Plan (NeGP), areas and Pillars of Digital India Programme, and Identification of Issues and Opportunities related to implementation of Digital India Programme in the country.

## 4. Pedagogy

The Programme strives to align its participants to basic knowledge of e-governance and its existing status in India, with special reference to Digital India Programme as well as to impart training skills to them in these areas of e-governance/ Digital India as per its objectives.

exercises based on government scenarios and simulated environment.

6. Course Duration
